CONTRACT

EXHIBITOR UNDERSTANDS AND AGREES TO THE FOLLOWING:

- 1. USA Theatres, hereafter called "Promoter", its agents, volunteers, or the Granada Avenue Gymnasium shall not be liable for property damage or personal injury to Exhibitor, its agents or employees, which may occur. Exhibitor waives any claim against Promoter and assumes all liability for loss or damage to Exhibitor's property entrusted to the premises. Exhibitor shall hold Promoter harmless and shall indemnify Promoter against all liability or expenses arising out of any claim or injury or damage to any person or property, together with all costs in connection with the defenses thereto.
- 2. Set-up of exhibitor spaces must be completed at show's opening and must remain set-up and open for business until show closing. Exhibitor spaces and aisles must be kept clear for safe access throughout show hours. Tables must be covered with approved flame retardant cloth.
- 3. Promoter reserves the right to demand removal by Exhibitor of any items which may not be in keeping with the show's image.
- 4. All municipal, state and federal requirements in connection with sales must be fulfilled.
- 5. This contract cannot be assigned without proper written consent of Promoter.
- 6. No exhibitor spaces may be shared without proper written consent of Promoter.
- 7. If any cause whatsoever makes it impossible to have the show, this agreement shall be terminated and Promoter shall not be liable for any resulting damage or claim.
- 8. Notification must be made in writing 30 days prior to show for cancellation of exhibitor space or Promoter shall have the right to retain exhibitor space rent.
